- 1780, March 2 Letter of Antho. Godwin at Nanum^d [Nansemond] to John James at Hampton. Regarding money due him.
- 1780, March 21 Agreement of the War Office, signed by
 Jas. Jones and Jas. Barron, with Mr. Moody for payment
 to him (for himself and tools) and Matt. Hatton, James
 Taylor jr., Daniel McCarty, William Godfrey, Francis F.
 Moody, Philip Moody jr., James Reynolds, Thos. Hatton
 (names of John Fisher and Bruton Sullivan scratched out)
 for their labor in the service of the state.
- 1780, April 25 Rockingham Co., Va. Reis Thomas proved an account before Henry Ewin and Ben. Harrison, justices.
- 1780, May 1 Thos. Meriwether, Major, 1st Virginia State Regiment, certifies that Richardson Lee, a soldier in the 1st Virginia State Regiment, has never drawn the suit of clothing allowed him by Act of Assembly for 1777.
- 1780, May 4 Ross, Shore & Company at Richmond gives receipt for three barrels of gun powder borrowed from the state. Witness: James Price.
- 1780, May 11 Commission to Reubin Matthias, Gent., as second lieutenant of militia of Princess Anne County. Signed by Th: Jefferson.
- 1780, May 11 Commission to Charles Moseley, Gent., as first lieutenant of militia of Princess Anne County. Signed by Th: Jefferson.
- 1780, May 11 Commission to Thomas Walker as captain of militia of Princess Anne County. Signed by Th: Jefferson.
- 1780, May 21 Letter of Alexr. Sinclair at Staunton to Governor Thomas Jefferson. Col Sampson Mathews not having immediate use for the money that he detained, he is sending it to the Governor by Mr. Smyth Tandy.

- 1780, May 21 A return of the troops of convention in Virginia. Signed by Jas. Hamilton, B. Genl. British: 1009; German: 1191 [broken down by rank].
- 1780, May 24 Will Robinson gives receipt to Capt.
 Triplett and Wm. Smith, inspectors at Leeds Warehouse,
 for satisfaction for two hogsheads of tobacco which
 were stolen.
- 1780, July 5 Receipt from Clarke & Talley at Page's Warehouse on Pamunkey River to Elizabeth Cown for one hogshead of tobacco.

28 Aug. 1783. King William Co., Va. John Hill made oath before Wm. Cowne he bought the hogshead of Eliza Cowne; the warehouses were burned.

1780, July 12 - Account of Messrs. Ballendine & Revely with the Commonwealth, 6 Sept. 1776-12 July 1780. Mentions: Edmd. Logwood, Jno. Reveley, Nath. Carrington, Mr. Byrd's executrix, Nicholas Spear, Jos. Carrington, Will? Webb, the Foundary at Westham and balance due the Commonwealth in pig iron. Signed by Archibald Cary, Geo. Carrington, James Buchanan, Turner Southall.

Another account, 30 June 1777-14 Dec. 1778, mentions Thomas James and Buckingham Furnace. Signed by Archibald

- 1780, July 20 Commission to Matthew Godfrey as County Lieutenant of Norfolk County.
- 1780, July 29 Letter of J. M. Galt to Geo. Muter.
 David Jones who is employed as orderly man to this station has moved his effects from York to Warwick Court House. It would be attended with great expense to convey them to Williamsburg by land carriage. He asks one of the country craft run down for them, which may be done at one tide. [Filed with 1781]
- 1780, Aug. 28 Charlotte Co., Va. List of 69 Negroes belonging to James Habersham brought into the State of Virginia.
- 1780, Sept. 14 Letter of W. Armistead at Richmond to Commissioners of the Tax for King William County. James Warren has been deputed to receive all the tobacco arising from the specific tax.
- 1780, Sept. 16 Court martial held for Northumberland County to enquire into the behavior of sundry mutinous and riotous persons who endeavored to excite muting and to resist the Act of General Assembly for recruiting

the quota of this state for the Continental Army.

Charles Clark appointed Clerk of this Court martial. John Humphries, John Hornsby, Thomas Shepherd, James Sullivan and Thomas Haynie being declared soldiers during the war, upon hearing witnesses, are acquitted.

Capt. Samuel Denny is ordered to have warned in a sufficient number of men, not less than thirty and officered, to take those persons that were concerned in the late riot.

It is ordered that the rioters who have not delivered themselves up be soldiers for eighteen months provided they will surrender themselves up in eight days.

Whipple, Ed. Hunt, Isaac Brown, Welcome Arnold, Capt. Kendrick, Elisha Carpenter, Josh. Grafton, Thos. Jones, David Laurence, Zeph. Brown.

[1780, Oct.] - Petition of members of the Goochland County militia, lately marched to Hillsborough in division, with shame and sorrow acknowledging the disgraceful rout. Being raw and ignorant of discipline and under officers (generally) as undisciplined as they, they were ordered not to fire until they had the word and then to advance with charged bayonets, which occasioned the confusion which followed. When they arrived at Hillsborough destitute of money and even clothes to wear, they applied to their officers for leave to procure such supplies as their poor families could furnish. Although such permission was not obtained, with the connivance of several of their officers they came in and were returning when they met their old companions who said they would not be received at headquarters but were deemed Continental soldiers for eight months. Having no intention of desertion, they delivered themselves up to the County Lieutenant and are now under marching orders. Most of them are very poor men with families of small children. They ask that the additional service be remitted.

1780, Oct. 10 - Goochland Co., Va. Booker Carrell and William Cosby depose that at the time some of the men from the county were about to leave camp on their way home, Capt. Edmund Curd asked Carrell if he was coming in with the others. Carrell replied he should come if able. Capt. Curd then said he would be damned if he did not, was he in the deponent's place, and gave Carrell a book to bring in.

David England and Nathan Wingfield depose that at Hillsborough after the rout in the south and destitute of clothes, they applied to Capt. Edmund Curd for leave to procure such necessaries as they needed. Capt. Curd said it was not in his power to give furloughs, but would come in, was he in their places.

David Mitchell, John Askew, Humphry Parrish and Robert Groom of the Goochland militia lately returned from Hillsborough depose that being almost naked after the loss of their clothes in the rout in South Carolina and desirous to come in for others, Capt. Edmund Curd told them he would do so was he in their places. Soon after Capt. Ballew came along the ranks and said publicly the soldiers were damned fools if they did not come in.

1780, Nov. 11 - John Allen at Hoods to Col. Muter at Richmond. Letter regarding materials and arms received and items needed to build the barracks.

1780, Nov. 15 - Benja. Day at Williamsburg to Col. George Muter in Richmond. Letter regarding hiring a Negro man and a tinman.
