 Als for y^e rest of my Estate I make my deare & loving wife my full & sole
 executrix the paying my debts

all to my will & desire is that my two Sonn Obedience & Joseph be at age when
 he attains to y^e age of eighteenth y^e old and then to enjoy his Estate and as for
 my Daughter Mary my will is that she shall be at age at fifteen y^e old
 I have sealed my p^resents of us

In the name of God Amen this 5th day of October 1673 being the fifth year
 of the Reigne of our Sovereign Lord Charles y^e second by y^e grace of God King
 of England Scotland France and Ireland know y^e that William Long of y^e
 County of Gloucester in y^e County of Virginia being Sick and weak in body
 but of sound and perfect memory present be given to God for y^e same and
 knowing y^e uncertainty of this life on earth and being desirous to best
 things in order do make this my last will and testament in manner & form
 following that is to say faithfull principles I commend my soule to Almighty
 God my Father spirituelle & bodie I shall receive full pardon and full
 Remission of my sins, and be saved by y^e precious death & merits of my
 blessed Saviour and Redeemer Jesus Christ and my body to y^e earth from
 whence it was taken to be buried in such decent and Christian manner as to
 my ex^rcut^res hereafter named shall be thought meet and convenient and
 as touching such worldly Estate y^e Lord in memory hath lent me, I do order
 give and dispose y^e same in manner and form following y^e is to say
 first I will that all third debts and duties as I owe in Right or Consuetude
 to any manner of person or persons whoever shall be well and lawfully intended and paid
 or bargained to be paid when convenient time after my decess first as touching
 my third hundred acres of land at Saint Marys in Somerset County in the
 Province of Maryland and my desire is that my loving wife Elizabeth Long do sell
 and equally divide the produce of it between William Long Elizabeth Long &
 my loving wife Elizabeth

Monday I do give and bequeath unto my Daughter Elizabeth Long three
 Cows a furred old mother and a furred heifer
 I do give and bequeath unto my Sonn William Long two Cows and
 two and violet

I give and bequeath unto my loving wife Elizabeth Long three Cows three head
 and five calves and one horse black Jack

I give and bequeath unto my loving wife Elizabeth Long my maid and my
 children Elizabeth and William Long all y^e rest y^e will B. W. W. W. W. W.
