otherwise to my before named Executors of this my last will
namely my Daughters Matilda West and my Grandson Anthony
West out of which Debt I only give unto my son Charles
Scarborough as a Legacye £1000 Shillings which I give in full
to him and to bar him of any further Claim or Right to any
part of my Estate for any damages he shall or may claim
herein I have hereunto set my hand & seal this 18th day of October
1691
