him & his heires Lawfully begotten by his body Item I give unto
my Grand Daughter Elizabeth all kins two hundred acres of Land
lying upon y^e head of William Parker & y^e head of y^e Land that
was Adam Michals to her and her heires for ever Item I doe
order that my Land att Mespongoos if my Exerutes meet wth a
conventionall to select for y^e good of y^e estate Item I give unto my
belovd wife one of my Exerutes her one Rydm Horse Item I doe
give unto my Grandsonne Southie Littleton one young Horse Item
I give unto my Grand Daughter Gartude Littleton one young mare
Item I give unto my two Exerutes my belovd wife and Daughter my
small estate equally to be divided betwixt them Item I give
unto my Grandsonne Sebastian Cropper my Ring & Croppers saddle
and case of spurs & Rapors & Bettle Item I give unto my belovd wife
my other riding saddle & y^e pillion stid has formerly been Item my
Exerutes shall pay all my debts & Legacies of this my last will
Item I revoke all other wills & testam^{ts}
