This Indenture made the twentieth day of February in the
 year of our Lord God one thousand six hundred ninety three and
 in the fifth year of his Reigne of our Sovereign Lord & Lady
 William and Mary King and Queen of England Scotland France
 and Ireland Defenders of the Faith &c Between Catharine
 Browman Widow Relict of Edmund Browman late of Accomack
 County in Virginia Gent^l deceased and Daniel Eham and Gertrude
 his wife all of the aforesaid County of Accomack of the one part
 and Matthias Tysen of the same place Planter of the other part
 Witnesse that whereas woth the said Catharine Browman &
 Gertrude the now wife of Daniel Eham are constituted and
 appointed Executors of the Last Will and Testament of the said
 Edmund Browman; and whereas the said Edmund Browman
 did in a certain clause of his said Last Will order that his Land
 at Mepango in the County of Accomack should be sold for the
 good of the State; and having met with a convention to sell it
 to dispose thereof for the good of the State & now wee the said
 Catharine Browman and Daniel Eham & Gertrude his wife
 doe by power & authority & consideration as hereunto moving
 and in consideration of seven thousand pounds of good Tobacco
 receipt whereof woth the said Catharine Browman & Daniel
 Eham & Gertrude his wife doe acknowledge and of every
 part and proce thereof doe for ever exonerate acquitt and
 discharge him the said Matthias Tysen his heirs Executors
 and admin^r and every of them by these presents have given
 and by these presents doth fully & lawfully and absolutely
 give grant bargain sell alien Implead and confirm
 unto the said Matthias Tysen his heirs and assigns for ever
 Three hundred acres of Land Situate lying and being for ever
 on the Northern parts partly therewith and partly by a Line
 of marked trees running from a fire marked standing by a
 Path side on the North side of the head of Mepango Creek South
 East and by East two hundred forty eight Poles to another fire
 marked thence for the Western bound^r South South West half a
 point Westwardly one hundred forty four Poles to another corner
