In the Name of God amen this fifth day of January 1765 according to the computation of the Church of England William Burton of Accomack County in Virginia being sick and weak in body but of good memory and sound mind praised to God for the same and knowing his condition of all things both on Earth and being desirous to make his goods and estate to dispose of that he has with good and lawful consideration both been pleased to comply with the last Will and Testament of said deceased and approved the following

I give and bequeath my soul into the hands of Almighty God who gave it me and my body to the Earth to be buried in decent Christian burial as by my Executors, Executors and certain Heirs of my bodyful resurrection in the last Jesus Christ
