 making void all wills and Testaments of me formerly made Desiring all my
 Just Debt^s may be paid and Satisfied - my soule I recommend to my maker
 and Redeemer my Body I comitt to y^e Earth at y^e discretion of my Ex^{ors}
 writing hereafter named Item as for what Estate itt hath pleased God
 to bestow upon I Give and bequeath as followeth viz
 I Give and bequeath unto my son Joseph Riggs and to his heirs for
 ever my Plantation whereon I now live with all my Land from y^e hog
 Penus against Baldy Hinmans with a straight to the end of the burnt
 ridge to where William Gott a Kessel for a Sloop Sloop from Phoebe to the
 line of the Glosb Land Item I Give and bequeath unto my son Joshua
 Riggs and his heirs for ever all the rest of my high Lands Napt to the
 School house Branch the rest of my Land being Swamp I Give Betwixt
 my two son for to Gitt Tenber Item my will is that my son
 Joshua shall not sell nor Dispose of his part of Land Except itt be to
 his Brother Joseph provided he will Give him the worth of itt Item
 I Give unto my Loving wife Rosanna Riggs all my personall or Mo^{ve}
 uable Estate during her widow hood but if in life she should Marry
 or die to be Equally divided amongst my Children Item I
 Give my muskett to my son Joseph and my own shooting Gun
 to my son John and my other Gun to my son Moss; Lastly I Doe
 ordain and Appoint my Loving wife Rosanna Riggs to be my sole
 Ex^{ors} up to this my Last will where unto I sett my hand and
 seal this Twenty fifth day of October 1726
