manner & form first & principally I resign my soul into w^e hand of Almighty
God my Creator who gave it me, afirely hoping in & through w^e merits of
my Beloved Saviour to obtain pardon & remission of all my sins and my body I
commit to w^e Earth where it was taken to be decently buried according to the
discretion of my Executor herein after named and for w^e world by Goods and Estate
w^e God hath endowed me with all I dispose and bequeath the same in manner
and form following: I promise I give and bequeath unto my Son Robert Watson
one Shilling & I here I give & bequeath unto my Son Peter Watson one Shilling
Item I give & bequeath unto my Son David Watson one Shilling —

John I Give & Bequeath unto my son Benjamin Watson one pair of pot Rack
John I Give & Bequeath unto my son Mose Watson my hand mill & one pair of pot Rack
John I Give & Bequeath unto my daughter Elizabeth Rigg one Shilling
John I Give & Bequeath unto my daughter Mary Bell one Shillings
John I Give & Bequeath unto my Daughter Annah Watson all my weareing
apparell w/ Smoothing board the Wooster Co. & my pad Saddle
Hence I give & Bequeath all d. rest residue & remanent of my Estate both within doon
and without after my funeral charges & debts paid unto my two Sons Benjamin
Watson & Mose Watson to be Equally Divided between them
Item my will and desire is that if my son Mose Watson deport this life before
he comes to d. age of eighteen that then my son Benjamin have, posses, &
enjoy his deceased brother's Estate, and my will & desire is y. my son Mose
Lives with his brother Benjamin till he comes to age & that my son Benjamin
take Care of his brother Mose Estate till he comes to age, & my desire is
that my son Benjamin take Care that his brother Mose have one years time
before he comes to age mose paying his brother Benjamin what he shall
or may be out about his learning out of his own proper Estate when he
shall be at age or receive the same my will & desire is y. no appr.
aisement be made of my Estate but if my son Benjamin choose one
indifferent person & my son Mose choose another to divide the Estate
between them. Lastly I nominate Constitute & appoint my son Benjamin
Watson my whole & sole Executor of this my last will & Testament & do
hereby utterly disallow Revoke & Disannull all other former wills by me made
concerning this to be my last will & Testament In witness whereof I have hereunto
set my hand & affixed my Seal w/ day & year first above written
