 owed by my Executor hereafter mentioned

I give and bequeath unto my Brother in Law John Townsend the two hundred
 Acres of Land w^{ch} I now live on it being w^{ch} land wth my loving father gave
 me by his deed of Gift Recorded in y^e Clerk's office

I give and bequeath unto Benons Morris w^{ch} son of hester Morris two new
 father Beedes one father Boulster four blankets three pinter dishes large
 nine plates two pots of fower Gallons & plates one new Rugge one Green
 pinter Spoones; and it is my will & desire y^e Benons Morris w^{ch} son of
 hester Morris shall be left att Liberty & be discharged from & by my Executor
 when he shall arrive to y^e age of eighteen years old to Refuse all such
 things as are mentioned into his own Custody they being for him to be
 delivered to him new and in good order as when they are Resolved unto
 y^e Charge or Custody of Executor hereafter mentioned

I give and bequeath unto my loving Mother in Law Sarah Townsend
 my gray Passing horse for best purpose

I give unto my loving Sister Isen marry ten yards of agathis

I give and bequeath unto my loving Sister Sarah Townsend shurteen yards
 of House, Lathly I give & bequeath unto my loving father Thomas Town-
 end all y^e Rest of my Estate not all Ready given to be made use of for
 y^e schooling & bring up Benons Morris to Reading and writing & y^e lands
 Benons Morris to be & Remain with my f^r father Thomas Townsend wh^{ch}
 he arrive to y^e age of eighteen & no longer
 And doe ordain constitute & appoint my loving father Thomas Townsend
 my whole & sole Executor of this my last will & Testament Revoking
 and thereby disannulling all other Wills here to for made or Couped to be
 made in witness whereof I have sett my hand & fixed my seale this
 20th day of April one thousand seven hundred & twenty

This Indenture made the fourth day of October Anno Domⁱ seventeen hun-
 dred & twenty Between Marke Esq^r of Anson-wick County Triklayer of y^e one
 part & Solomon Esq^r of the same County Triklayer of the other part With-
 in witness that y^e Marke for & in consideration of forty pounds Sterling to
 him y^e Marke in hand payd by the D^r Solomon before the signing
 & delivery of these p^{ts} But the Receipt whereof the D^r Marke doth hereby
 acknowledge Hath granted bargained sold Aliened enfeoffed & Confirmed
 and by these p^{ts} doth grant bargain sell Aliened enfeoff & confirm
 unto the D^r Solomon his heirs & assigns for ever all the right title
 & Interest which he y^e Marke now hath or heretofore had to that
 part of marsh & Hamacks lying & being on the North side of
 Hunting Creek beginning at a ditch by the said Marke running from
 West ditch into Timber Creek & thence running down to the Mon-
 th of y^e Timber Creek thence down Hunting Creek to the Mon-
 th of y^e Harroes Gutt thence up the D^r Gutt to the Head thereof
 thence running by a line of Marked Trees South East
 & by East to the af^d ditch containing by estimation two
 hundred & fifty acres be the same more or Less which
