sawed by my Executor here after named

I give and bequeath unto my Brother in Law John Townsend the two hundred
Acres of Land wh ch now lie under it being d. Land wch my loving father gave
me by his deed of Gift Recorded to be in d. Clarke office —
Item I give and bequeath unto Dennis Morris d. son of Peter Morris two new
father beddes one father boulster four blankets three pinte dishes Large
nine plates two potts of four Gallons a peale one new Rugga one Dozen of
Pater Spoons; and it is my will & desier of benenes moress d. son of
Peter Morris shall be lett att liberty & be discharged from & by my Executor
when he shall arrive to d. age of eighteen years old to Reserve all such
things as are mentioned into his own Custody they being for him to be
delivered to him new and in Good order as when they are Reserv'd unto
d. Charge or Custody of Greater hereafter mentioned —
Item I give and bequeath unto my loving Mother in Law Sarah Townsend
my gray Pashley horse for her proprie

Item I give unto my loving Sister Jane marry tenne yards Tagothie
Item I give and bequeath unto my loving Sister Sarah Townsend thurteen yards
of Stoufe, Lastly I give & bequeath unto my loving father Thomas Townsend
and all d. Rest of my Estate not all ready given to be made use of for
d. schooling & bring up Dennis Morris to Reading and writing & d. land
Dennis Morris to be & remain with my d. father Thomas Townsend who
be arrue to d. age of eighteen & no longer
and Doe ordain constitute & appoynt my loving father Thomas Townsend
my whole & sole Executer of this my Last will & Testament Revoking
and Revoking all other Wills bee to for made or Cusfed to be
made in witness whereof I have lett my hand & fix'd my seal this
26th day of April one thousand seven hundred & twenty

This Indemnity made the fourth day of October Anno Dom. Seventeen hundred
and twenty Between Marke Dwell of Accrington County Bricklayer of d^r one
part & Solomon Dwell of the same County Bricklayer of the other part with
the d^r that d^r Marke for & in Consideration of forty pounds Sterling to
him d^r Marke in hand paid by the d^r Solomon before the sealing
& delivery of these presents the Receipt whereof the d^r Marke doth hereby
acknowleage hath granted bargained sold Alene enfeoffed & confirmed
and by these presents doth grant bargain sell Alene enfeoffed & confirm
unto the d^r Solomon his heirs & Assignes for ever all the right title
& Interest which he d^r Marke now hath or heretofore had to that
part of marsh & Hamacks lying & being on the North side of
Hunting Creek beginning at a ditch by the said Marke running from
West ditch into Timber Creek & thence running down to the mouth
of d^r Timber Creek thence down Hunting Creek to the mouth
of d^r Marsh Cut thence up the d^r Cut to the Head thereof
thence running by a line of marked Trees South East
& by East to the afo^d ditch containing by estimation two
hundred & fifty acres be the same more or less which
