In the name of God amen I Joseph Stockley Sen^r in the County of Accomack with the Colony of Virginia Yeomen being in firm of Body but of sound mind & Perfect memory Praised be God therefore Renouncing Revoking and making void all former Wills and Testaments whatsoever heretofore by me made in Writing or otherwise but do make and Ordain this to be my Last Will and Testament in manner and form following viz^t Imprimis I bequeath my Soul into the Mercyfull hands of Almighty God and my Body to the Earth to be Decently buried therein at the Discretion of my Executors herein after named and as to my worldly Goods and Estate I Give Devise & bequeath the Same as follows Item I give unto my Son Joseph Stockley all that Tract of Land whereon he now Lives Containing three hundred And Sixty four Acres to him his heirs and Assigns forever: Item I Give the Plantation whereon I now Live between my Two Sons Alexander & Elias Stockley Beginning at a Creek Called Assaweman and Running up the said Creek and branch to a white oak Stooping by an old rode

from thence to a Red oak Saplin and from thence to a walnut Tree and from thence west

two of the best Ruggs and four blanketts and one pair of Sheets and three of my Smallest
Iron potts with the pott hooks thereto belonging and one pewter Dish three basons eight
plates and Eighteen Spoons and one Gun and two Iron wedges one plough and harrow and all
my Iron working tools and my Chest with all my warring Cloths and all thats in it made and
unmade and all my sheep and hogs and my riding horse Pistols and holsters: Item I Give
and bequeath unto my Grandson Joseph Stockley my Small Gun
