file* In the Name of God Amen this 1st of the Month of June in the Year of 1789 I John Lilly
of Albemarle County and Colony of Virginia being very sick weary of Body but of per-
fect Mind & of Memory thanks be to God for it therefore calling to mind the Mortality of
my Body & knowing that it is appointed for all men once to die do make & Ordain this my last
Will & that is to say principally & first of all I lend to my well beloved Father & Mother a Negro
Boy dancing, dancing Lovers and a few more because I give to my brother William Lilly three
Negro Bells he paying to his Sister Mary Lilly fifteen pound & I likewise give to my brother
William Lilly my horse bidle saddle & appoint my father Edmund Lilly my whole Executor
that is to say principally give my soul into the hands of God & my body I recommend to the
Earth to be buried in Christian like manner at the discretion of my Executor not doubting
but at the general Resurrection I shall receive the same by the mighty power God so I
acknowledged this to be my last will & Testament all Others to be void & of none Effects
& this only to be in full force as Witness my hand I shall

This Last will & Testament was presented in Court by Edmund Lilley the Executor
therein Named & proved by the Oaths of William Turbush & William Martin
two of the Witnesses thereto & Ordered to be recorded & on the motion of the said
Edmund Lilley who made Oath according to Law Certificate is granted him
for Obtaining & probat thereof in due form Giving secretly on which he
with William Turbush & William Martin has Secretaries Entered into &
Acknowledged their Bond for the true & faithful performance of the said Will

Thomas } In the Name of God Amen I Edward Thomas of Worcester County &
Will } parish of Tillotson being in a declining condition of body but of sound
mind & Memory thanke be to Almighty God do make constitute & appoint
this to be my Last Will & Testament First I recommend my soul to God that
gave it me & my body to the Earth to be decently Buried as my Executors
shall think fit and as to my worldly Estate I then left to dispose of in manner of
former followeth Viz that is to say I then Give & bequeath to my eldest son William
Thomas one hundred Acres of Land part of the Tract I now live on & bounded as
followeth to wit beginning at John Thomas's upper Corner on the River running on
his said line to the back line then ^{at} the back line to a new line on the North fork
of the Millstone branch so down the ^{said} branch on a new marked line to the Creek
so down the said Creek to the River then down the river to the first Station
(both the same more or less) Excepting the Use of the Orchard during my life which
said Land I give to him & his heirs forever & also Give him my Negro Girl
Phibo and all her Increase to him & his heirs forever I also Give him his cattle
that he has in Possession & his hogs which in this Possession & that to be his
part I then Give & bequeath to my son John Thomas as the Remainder of the
Land I now live on which said Land I Give to him his heirs forever I also
Give him one bed & Furniture & that to be his part I then Give & bequeath
to my Daughter Martha Goolbsy Six pounds a Current Money of Virginia
which said Six pounds not to be paid to her till three years after my Death

Item I give to my Daughter Susannah Stephens the bed she lies on & furniture
 shelling basket Money to be paid three years after my Death I am given to
 my Daughter Elizabeth Thomas my pound current money to be paid three years
 after my decease Item my will & desire is that the rest of my Estate not
 mentioned of what kind or whatever I lend to my well beloved wife Mary Thomas
 in Law of Dower and at her Death my Desire is that my Estate be Equally
 Divided between my three Daughters before mentioned Item my will
 & pleasure is that my Estate be not appraised Item I constitute &
 appoint my brother John Thomas & my son John Thomas Executors of
 this my Last Will & Testament Item I publicly declare this to be
 my last will & Testament revoking all other former Wills I have made
 which I have hereunto set my hand & seal this the thirtieth day of
 December 1758

At a Court held for Alameda County the 14th day of March 1760
 This Will was presented to Court by John Thomas & John Thomas the Executors
 therein Named proved by the Oath of Thomas Thomas one of the Witnesses thereto
 & on the Motion of the said Executors who made Oath according to Law
 Certificate is Granted them for obtaining a probate thereof in due form
 giving security on which they with Thomas Topley their security entered
 into and Acknowledged their Bond for the due & faithful performance
 of the said Will &

 thereto & Ordered to be recorded
