Be it remembered that on this 19th day of June 1819 before me Alexander Moore Register of Wills for the County of Alexandria in the District of Columbia, came Mat-
 thew Robinson one of the witnesses to the within last will and Tes-
 tament of Christopher Gird deceased, and made oath upon the Holy
 Evangelists of Almighty God, that the Testator signed and ac-
 knowledged the same in deponents presence and that he together
 with Edward Burhe and Matthew Seesmith the other witnesses had
 subscribed their names as witnesses to the same in the Testators pre-
 sence and at his request and that the Testator was of sound mind.
 Also appeared Thomas Cruise and Guy Atkinson two of the sub-
 scribing witnesses to the Codicil annexed to the said Will and made
 oaths according to law that the Testator signed and acknowledged
 the same in their presence, when he was of sound mind, that they
 subscribed their names as witnesses in the Testators presence and at
 his request. And the said deponents also severally deposed that the said
 Will and Codicil and the signatures thereto are wholly in the hand writing of
 the Testator. And on this day the 22nd of June 1819 Letters Testamentary were grant-
 ed to Hannah Gird the executrix named in the said Will.
