They are to be my whole and sole Executors and I appoint their Father William to be their guardian to see that this my will be carried into complete and full effect but in case of his death I appoint John Sumner, Matthew Seesmith & Charles Slade to be their Guardians, and with regard to the undivided real property between Mr. Carrie and myself I will that Mr. Carrie or in case of his death the said John Sumner Matthew Seesmith and Charles Slade be at full and free liberty to dispose of the same either by sale or as annual ground rent for the benefit of my Executors & Executrix, and I hereby fully authorize him or them to act by the same as they shall think proper. And as to Dick Senna and Sennas child it is my will that the two former be liberated in ten years from the period they were purchased, and the child when it shall have arrived at the age of twenty four as witness my hand and seal this Sixteenth day of November 1821
