he paying thereout my funeral expenses and all my just debts also two hundred
dollars each to my wife Susannah Kennedy and my three Daughters Sarah Gertrude
Elyza Kennedy and Susannah Kennedy within twelve months after my decease

My dwelling house two Store Rooms and lot of Ground on King Street as par-
shaded by me in Fee simple from the Executors of Jacob Fortney I give and bequeath the
one third to my wife Susannah Kennedy with all my Household furniture one
third each to my daughters Elyza Kennedy and Susannah Kennedy their Heirs
the excepting that at the death of my wife her said third of the above property shall
pass to my daughter Sarah Gertrude for her life & forever.

And whereas my deceased brother the Rev. Dr Thomas Kennedy Bachel-
late vicar of Kilmore in the County of Down in the Kingdom of Ireland hath
by his last will and Testament bequeathed to me in Reversion on the death of his
widow Sarah Kennedy Bachel of Downpatrick in the County of Down in Ireland
certain Lands and estates in the Counties of Down and Tyrone in that Country
together with a four Story Brick Dwelling house and ware House on Lower Linn
Quay in the City of Dublin. Now I do hereby give and bequeath the said Lands
and Estates with the said House and ware House in like manner to my son
Andrew J Kennedy; he conforming to all the Provisions and stipulations in the
said Will and moreover as soon as he shall come into possession of said Estates
paying or causing to be paid to his three Sisters Sarah Gertrude Elyza Kennedy
and Susannah Kennedy out of the rents thereof two hundred dollars to each
my year during their natural lives.

And I do hereby constitute and appoint my wife Susannah Kennedy and
my son Andrew J Kennedy my Executors and Administrators to this my last Will
and Testament. In case of any difference arising between my said Executors
or my daughters respecting the construction of any part of this my last Will,
I do hereby appoint Thomas Swann Esq my lawful attorney to settle and decide
between the parties and to conduct any suit at Law they may be obliged to defend
or to commence for the recovery of any debts due to my Estate in the United States
I do also appoint John Craig Esq attorney at Law of Downpatrick in the
County of Down and Kingdom of Ireland my lawful attorney and agent
to manage the concerns of my Estate in that Country.
