The Condition of the above obligation is such that if the above bound Matthew Robinson (Guardian of the Person of James Maddock deceased) his Executors and Administrators do and shall well and truly perform the office of Guardian and in all respects conform to the law in such cases made and provided then this obligation to be void else to remain in full force

The Condition of the above obligation is that if the said Catherine Piper Administratrix of the goods Chattles and Reverts of James Piper deceased do make a true and perfect inventory of all and singular the goods Chattles and Credits of the said deceased which have or shall come to the hands possession or knowledge of her the said Administratrix or in the hands or possession of any other person or persons for her and the same so made do exhibit un to the said Orphans Court when she shall be thereunto required by the said Court and such goods and Chattles do well and truly administer according to law and further do make a just and true account of all her doings and things therein when thereto required by the said Court and all the rest of the said Goods Chattles and Credits which shall be found remaining upon account of the said Administratrix the same being first examined and allowed by the Judge of the said Court for the time being shall deliver and pay unto such persons respectively as are entitled to the same by Law. And if it shall hereafter appear that any last Will and Testament was made by the deceased and the same be proved in open Court and the Executor obtain a certificate of the probate thereof and the said Administratrix do in such case being thereto required render and deliver up her Letters of Administration then this obligation to be void else to remain in full force
