The Condition of the above obligation is such that if the above bound Horace Field & Guardian of Matilda Lee Auguely Elizabeth Harr Auguely and George Kendall Auguely Orphans of George Auguely deceased his Executor and Administrator do and shall well and truly pay and deliver unto the said Orphans all such Estate or Estates as now or hereafter shall come to the hands or possession of the said Guardian when the said Orphans shall attain lawfull age or when the same required by the said Court and also shall well and truly save harmless and indemnify the said Judge of the said Court and his successors in Office from all trouble and damage that shall or may arise about the said Estate then this obligation to be void else remain in full force and virtue.

And such quo as Chattels and Credits do well and truly administer according to Law and further do make adjustment in his account of all his actions and doings therein when thereto required by the said Court and all the rest of the said goods Chattels and Credits which shall be found remaining upon account of the said Administrator the same being first examined and allowed by the judge of the said Court for the time being, shall deliver and pay unto such persons respectively as are entitled to the same by Law. And if shall here after appear that any last will and Testament was made by the deceased and the same beforever in Court and the Executor obtained a certificate of the probate thereof and the said Robert Taylor do in such case bring required render and deliver up his Letters of Administration.
