I am now in a very low state of health at my grand fathers. should I never be able to leave this I wish to dispose of my property as follows to wit

I give to Eliza M Donale Two hundred dollars, and my watch

To my Aunt Elanor Wallace (if I die here) thirty dollars to be paid in cash

To my brother John Milligan to be expended in giving him an education and preparing him for a trade or some profession five hundred dollars

To my Sister Sarah Milligan one hundred dollars To my Aunt Anne Milligan of George Town I give as a small testimony of the high esteem in which I hold her Fifty dollars To my Aunt Cor Wallace (if I die here) I give twenty dollars. I do hereby exonerate my father from a debt due me of Fifty seven and 50 dollars. I give all my clothes to my Brother Robert, my best pin to give to Stephen Macdonald. The remainder of my estate after paying all necessary funeral expenses &c I wish to be divided equally amongst my three sisters Hannah Margaret, and Elanor, and my two brothers Joseph and Thomas, and to be expended as far as possible in educating them

This paper I publish & declare as my last will & testament and as executor thereof I do hereby appoint my Uncle Joseph Milligan & Mr Alexander M Donale of the City of Washington.

I am at this moment (through the mercy of a kind providence) blest with my perfect senses though reduced to so weak a state of body that I expect to live but a very short time & have therefore been induced to write this instrument which though informal & roughly done I wish as before declared to be considered as my last will and testament Given under my hand & seal in Perry County in the State of Pennsylvania the eleventh day of August in the year of our Lord one thousand eight hundred and twenty
