

I Thomas Murray of Alexandria in the District of Columbia do make and utter this my last will and testament, hereby revoking all former wills by me made

First I give to my daughter Margaret my lot adjoining Sullivan gardens, to her and her heirs forever

Secondly I desire that my dwelling house on Duke street in the town of Alexandria, be sold to the best advantage, by my Executors herein after named, and out of the monies arising from such sale that they retain the sum of one hundred dollars, to be carefully applied towards the education of my son Thomas Jefferson Murray, the balance to be applied to the payment of all just claims against me

Thirdly I give to my daughter Margaret and my son Thomas Jefferson all the residue of my property whatsoever, and wheresoever, to be equally divided between them.

I appoint my trusty friends John Cochran and William Vetch, executors of this my last will and testament recommending to their care under all circumstances my dear children. In testimony whereof I have hereunto set my hand & seal this 17<sup>th</sup> day of January 1821

Be it remembered that on this 12<sup>th</sup> day of February 1821 before me Alexandria Moore Register of Wills for the Town and County of Alexandria in the District of Columbia came Thomas Murray Junior, William White and Jonathan Wallace witnesses to the last will and Testament of Thomas Murray deceased and proved the

same in due form of law. And on the 13<sup>th</sup> day of the same month and year William Vetch one of the Executors named in the said Will qualified with bond and gave bond and security according to law, and Letters Testamentary were granted him. John Cochran the other executor named therein renounced his appointment and refused to act.

Know all Men by these presents that we William Vetch, John Cochran and Thomas Jacobs are held and firmly bound unto Robert Young Esquire Judge of the Orphans Court of Alexandria County in the District of Columbia and his successors in office in the sum of five hundred dollars lawfull money of the United States to the payment whereof well and truly to be made we bind ourselves our heirs executors and administrators jointly and severally firmly by these presents sealed with our seals and dated this 13<sup>th</sup> day of February 1821

The condition of the above obligation is such that if the above bounden William Vetch shall <sup>well</sup> and truly perform the office of Executor of Thomas Murray late of Alexandria County deceased according to law, and shall in all respects discharge the duties thereof which are required by law as Executor of said deceased without any injury or damage to any person entrusted in the faithful performance of said office then the above obligation shall cease it shall otherwise remain in full force and virtue in law
