

Know all Men by these presents that we Margaret Simms, Charles Douglass and Robert Brockot are held and firmly bound to George Gilpin Esquire Judge of the Orphans court for the county of Alexandria in the district of Columbia and his successors in office in the sum of five thousand dollars, to the payment whereof well and truly to be made to the said Judge and his successors in office we bind ourselves our heirs executors and administrators jointly and severally firmly by these presents sealed with our seals and dated this 12<sup>th</sup> day of April 1808 -

The Condition of the above obligation is such that if the above bound Margaret Simms administratrix of all and singular the goods chattels and credits of Thomas Simms deceased, do make or cause to be made a true and perfect inventory of all and singular the goods, chattels and credits of the said deceased which have or shall come to the hands possession or knowledge of the said administratrix or into the hands and possession of any other person or persons for her, and the same do make to exhibit unto the Orphans court for the county of Alexandria when thereto required by the said court, - and the same goods chattels and credits so will and truly administered according to law - and a further do make a just and true account of his actions and doings therin when thereto required by the said court. And still the rest of the said Goods chattels and credits which shall be found remaining upon the account of the said administratrix the same being first examined and allowed by the Judge of the said court for the time being shall deliver and pay unto such persons respectively as are entitled to the same by law. And if it shall hereafter appear that any last will and testament was made by the deceased and the same deposited in court and the Executor obtain a certificate of the probate thereof and the said Administratrix claim such case being required to deliver up her letters of Administration then this obligation to be void else to remain in full force -
