The Condition of this above Obligation is such that if the above Bound Alexander Williams Guardian of Elizabeth Buggess, his Executors and Administrators do and shall well and truly pay unto the said Orphan all such Estate and Estates as now is a hereafter shall come to the hands or possession of the said Guardian as soon as the said Orphan attains lawful age a when should require by the said Court & shall well and truly save harmless and indemnify the said Judge, his Heirs, Successors from all trouble and Damages that shall or may arise about the said Estate, then this Obligation to be void and of none effect else to remain in full force & Value.
