 The Conditions of the above obligation is such that if the above named Catharine Pugh Guardian of Isaac Pugh and Sarah Pugh her Executors and Administrators do and shall well and truly pay unto the said Cyphus Court all such Estate and Estates as now is or hereafter shall come to the hands and possession of the said Catharine Pugh as soon as the said Cyphus Court shall require when thereunto required by the said
