KNOW all men by these presents, that we James Craik, James Keith & James Bruce Nickolls, are held and firmly bound to George Gilpin Esquire, Judge of the Orphans Court for the County of Alexandria, in the District of Columbia, and his successors in office, in the sum of four thousand Dollars, to the payment whereof well and truly to be made, we bind ourselves our Heirs, Executors and Administrators, jointly and severally firmly by these presents - Sealed with our seals and dated the 21st day of January 1809.

The Condition of the above Obligation is such that if the above bound James Craik, Guardian of James C. West, & Mary C. West, Ann M. West & Roger West, orphans of Roger West deceased; his Executors and Administrators, do and shall well and truly pay unto the said Orphans, all such Estate and Estates, as now is or hereafter shall come to the hands and possession of the said Guardian, as soon as the said Orphans, shall attain full age, or when therefo required by the said Court, and shall well and truly save harmless and indemnify the said Judge of the said Court, and his Successors in office from all Trouble and damage that shall or may arise in about the said Estate, then this Obligation to be void, else to remain in full force and virtue.
