The Condition of the above obligation is such that if the above bound Stephen Moore Guardian of Richard Smith his Executors and administrators do and shall well and truly pay unto the said Orphan all such Estate and Estates as now is or hereafter shall come to the Heirs and possession of the said Stephen Moore, as soon as the said Orphan attains the lawful age or when thereto required by the said Court, shall well and truly save harmless the said Judge and his successors from all trouble and damage which shall and may arise about the said Estate then this Obligation to be void else to remain in full force and virtue
