 this 25th day of April A.D. Eighteen hundred & seventy
 one.

 motion of Henry P. Carson the Executor therein named he
 is allowed to qualify. Whereupon he executed a Bond
 with Mo. A. Carson his security (who made oath as to his
 sufficiency) in the penalty of 500 & waiving the Homestead
 exemption and conditioned according to law. And thereupon
 the said Henry P. Carson took the oath prescribed by law
 and Certificate is granted him for obtaining a probate of
 the said Will in due form.
