Item I give and bequeath to my loving Wife Mary Moore all my Land I bought of Coll. Theodorick Bland on Amelias County Joining the said Coll. Tho. Bland during her life time or Widowhood, likewise my Negro Wench Tabb

Item I give and bequeath to my Son Brittain Moore the Dwelling and Plantation whereon I now live to the Corner Pine Tree adjoining Mr. Friedrichs Ford from thence to the first white Oak adjoining St. John Tuckers thence to the first slash to a corner Hickory I have marked there being One hundred & seven more or less after my Wife's death or Widowhood

Item I give and bequeath to my son Anderson Moore after my Wife's death or Widowhood the other part of my Land with all the logs and Branches thereunto belonging containing One hundred & seven more or less

Item I give and bequeath to said Wife Mary Moore for her use during her life or Widowhood the Negroes as follows viz my Will, Charles, Sue young Hannah & Tom then to be divided as I shall direct

Item I give and bequeath to my son Brittain Moore my Negro Girl Sue after my Wife's death or Widowhood

Item I give and bequeath to my son Anderson Moore my Negro Girl Hannah after my Wife's death or widowhood

Item I give and bequeath to my Daughter Winney Moore my Negro Wallow Will after my Wife's death or widowhood

Item I give and bequeath to my Daughter Susannah Moore my Negro Boy Charles after my Wife's death or widowhood

Item I give and bequeath to my son Eppes Moore my Negro Boy Tom and in case either or both of my sons Brittain or Anderson Moore should die without heir then my Will is that my son Eppes Moore

shall inherit what I have left to my aforesaid Sons
Brittain Moore and Anderson Moore after the death
or widowhood of my aforesaid Wife Item I give and
bequeath to my Wife Mary Moore all my Stock of cattle
of whatsoever denomination they may be of likewise all
my household furniture be there more or less out of which
Stock and furniture she my Wife is to give my Son James
Moore a Cow and half my Son William Moore a Cow and
half my Son David Moore a Cow & half and my Daughters
Sarah and Molly Moore one Cow & half each when they
be of age or before if she shall think proper she is also to
give my Daughter Molly Moore one Featherbed the
above Stock &c I give to my Wife during her lifetime
& widowhood, after her death or widowhood then to be
divided between my three Sons viz Brittain Anderson and
Eppes Moore equally they three allowing my two Daughters
Winney and Susannah Moore one Cow and half each
Item to William Moore I give my half Stock Gun, to
Brittain I give my Speckled Stock Gun to Anderson I
give my great Gun Item I give and bequeath the
remaining part of the money due me from Col. Frederick
Bland arising from the Land I sold him be it more or
less to my Wife Mary Moore Item it is my Will that
John Steagal and Winifred Steagal live their lifetimes
on my Plantation provided they take care of my family
Item I give and bequeath to my Son John Moore Stephen
a Fellow Item I give and bequeath to my Son William Moore
after the death of Mr. Ben Moore those Negroes he has of
mine my Negro Boy Jaim Item I give and bequeath to my
Son James Moore my Negro Bobb Item I give and
bequeath to my Daughter Mary Moore my Wench Sues
Item I give and bequeath to my Daughter Sarah Moore
my Negro fellow Tom Item I give and bequeath to my
Son David Moore my Negro Pompey and after the death
of my Wife or her being no longer a Widow I give to my
Son David Moore my Negro Wench Tabb Item I leave
my Wife sole Executrix of this my last Will & Testament
