Following (to Wit)

Tract of land whereon I now live lying on West Creek containing
by estimation & seven or eight Acres more or less to him his
Heirs and assigns forever, but that my two daughters Anna
and Martha young live on their said land as long as they
shall remain unmarried, & after the death of said son Drury
the said boy (named) & the said one young more or less of
the said tract of land one feather bed & Furniture & one cow
& calf to him his Heirs and assigns forever

I Give and bequeath to my daughter Anna Young one
Negro girl named Liza one feather bed & Furniture & one
cow and calf & all which I give to my said daughter
Anna her Heirs and assigns forever

I Give and bequeath to my daughter Martha Young
one Negro boy named Dick one feather bed & Furniture
and one cow & calf & her Heirs & assigns forever

Item, my Will and desire is that my sheep, tools, and
New Chairs, and one half a canner which is now in my possession
be Equally Divided among my three Children Drury, Anna &
Martha, ... Item my Will and desire is that all the residue
Of my Estate of Every kind be sold by my Executors & the
Money arising from the sale thereof be first Applied in
Paying my Just Debts & Funeral Expences and the remainder
thereof be Equally Divided Among my Following Children
William, John, Allen, Ridley, Stephen, Elthorn & Samuel
and my Grand Son Frederick Brown to them their Heirs
and assigns forever, ... I do hereby constitute & appoint
my Friend Thomas Bolling & Munford and my Son Drury
Young Executors of this my last Will & Testament in
Witness whereof I have hereunto set my hand & Affixed my
Seal this Twenty Second day of November Anno Dom one
thousand Seven hundred and Seventy seven
