

In the Name of God Amen, William Crawley son of Amelia County being of perfect Sense and Memory do make this my last Will and Testament in Manner following

I Give unto my Daughter Elizabeth Jones two thousand five hundred pounds Current money or twenty five thousand weight of Tobacco at the Option of my Executors, to pay her either the money or tobacco Which I give to her and her heirs forever

I Give and bequeath unto my daughter Catherine Ward two thousand five hundred pounds Current money or twenty five thousand weight of Tobacco at the Option of my Executors to pay her either money or Tobacco which I give to her & her heirs forever, I Give and bequeath

unto my daughter Martha Crawley two thousand five hundred pounds Current money or twenty five thousand weight of Tobacco at the Option of my Executors to pay her either in money or tobacco I also give unto my Daughter Martha, fifteen Negroes as follows, Isaac, Sarah & Eight of their Children, Aaron, Betty, Jemme, Lida, Peg, Sara, Pucky & Wsee, Rachel and Betty her daughter, Matt daughter of Pheby, Hall Son of Lida & Aggy daughter of Matt I also give unto my daughter Martha two feather beds with such furniture as belongs to them, all which I give to her and to her heirs forever

I Give and bequeath unto my daughter Nancy Crawley fifteen Negroes none of them to be such as are Rendered Useless by Old Age or infirmity I also give unto my daughter Nancy two thousand five hundred pounds Current money or twenty five thousand weight of Tobacco at the Option of my Executors to pay her either in money or tobacco all which I give to her & to her heirs forever

I Give unto Peter Robinson three hundred pounds current money to him and his heirs

I Give and bequeath unto my Son David Crawley two plantations in Amelia County one on the South side of Beaver bond branch the Other on the North side of Deep Creek whereon he now lives with the one half of my land between Deep Creek & Beaver bond branch ad joining the two plantations to be laid off to him by a line from Deep Creek to Beaver ^{bond} branch all which I give to him & to his heirs forever, I Give and bequeath unto my Son John Crawley the other half of my land lying between Deep Creek & Beaver bond branch in Amelia County with one plantation thereon

All which I give to him & his heirs forever.
I him I give and bequeath unto my Son William Crawley
one plantation in Amelia County with three hundred and
Eighty acres of land adjoining the plantation between
Deep Creek & West Creek I also give unto my son William
seven hundred & fourteen acres of land in Amelia County
lying in the Fork of Namaroon Creek with a plantation
and Water Grist mill thereon, I also give unto him five
hundred & sixty one acres of land with a plantation thereon
lying on Nottoway River in Dinwiddie County all which lands
& plantations I give to him and to his heirs forever.

I him I give and bequeath unto my Son Benjamin Crawley
my plantation I now live on with all my land adjoining the
plantations on the Southeast side of Deep Creek & on both
sides of the Sweethouse Creek with a water Grist Mill thereon
in Amelia County which land & plantation and mill I give
unto my Son Benjamin and his heirs forever.

I him I give and bequeath all my Negroes or Slaves not before Willed
or given to be equally divided to & amongst my four Sons David Crawley
William Crawley, John Crawley & Benjamin Crawley I also give
my Stock of horses, Cattle, hogs, sheep &c. to be Equally divided
to and amongst my four Sons, I also give my feather beds not
before Willed or given to be Equally divided to & amongst my four
Sons all which I give unto my four Sons and to their heirs forever
my Will and desire is that if either of my Sons shall die before
he becomes of lawfull age or marry's his part shall be equally
divided amongst the Surviving Brothers.

My Will and desire is that my Daughter Nancy Crawley shall be
gentlely educated & maintained at the Expence of Estate.
I give my household furniture not before Willed or given such as
Chairs, Tables, Desks also the one half of my Kitchen Furniture
as also the half of my Silver Plate & Table furniture as dishes, plates
&c. also one silver ^{watch} all which I give unto my Son, W^m Crawley
I give the Other half of my Silver Plate & the half of my Kitchen
and Table Furniture unto my Son David Crawley.
I him I give one piece of land, containing six hundred & fifteen Acres

Which I purchased of William Randolph lying in Amelia County on the Beaver bond branch, and every other part of my Estate not before Willed or given to be Equally divided to and Amongst my four Sons David Crawley, Wm Crawley, John Crawley and Benjamin Crawley all which I give to them & to their heirs forever, My will and desire is that my Estate shall Not be Appraised I do Appoint my Son David Crawley Guardian to my three Youngest Children, John Crawley, Benjamin Crawley & Nancy Crawley untill they shall become of lawful age I do constitute and Appoint Henry Anderson, Tho. Griffith Esqrs, my Sons David Crawley & William Crawley Executors of this my last Will and Testament, Witness my hand this Seventeenth day of August one thousand Seven hundred & Seventy Nine

My Will and desire is that the profits of my daughter Nancy Crawleys Fortune given her in my Will shall be Applied towards her maintainance & Education and if more should be Wanting to be made up out of my Estate, Witness my hand this twenty first day of February one thousand Seven hundred & Eighty
