In the name of God Amen I William Stewart of the
county of Amelia being very sick & weak but in perfect
senses & memory do make Publish & declare this to be my
last Will & Testament First I give my soul to almighty
God who first gave it me and my body to the Earth to be
decently buried at the discretion of my Executors And as to
my worldly Estate the Lord hath been pleased to bless me --
with I give and devise in manner as follows Viz I term
it is my Will and devise that my Land containing One
hundred and sixty four acres be equally divided between
my six children, John, William, Edward, Sally, Charles and
Mary Stewart, my beloved Wife Mary Stewart to have an
equal Part with my children Item it is my Will & Desire
that my Slaves Hannah and Sarah with their Increase
be equally divided between my wife & children, each to

have those proportionable Part agreeable to the division of
my Land Item it is my Will and desire is that all my
Personal Estate be divided equally amongst my six children
except one feather bed I give and bequeath to my beloved wife
it being the best Bed I have it is my Will and desire that
all my Estate be kept together for the support of my children
and wife and I desire that when my son John shall
come to the year of Twenty one then for my Estate to be
divided as above mentioned every thing that I possess both
real and personal if any of my children or wife shall
die before my eldest son shall be of age then it is my -
Will and desire that my Estate be divided equally among
those that are alive, my desire is that my Gun be sold
towards paying my debts and the support of my children
I constitute and appoint my Neighbours Thomas Whitworth
Senr and Thomas Whitworth Junr Executors of this my
last Will and Testament revoking and making void
all former Wills by me made as witness my hand and
Seal this fifth day of August 1774

I do declare to this my Will Whereas the within mentioned
division of my Personal Estate is not so clear as I would
have it My will and desire is that at the said division
my wife's share equal with my children and that my
said Personal Estate be divided into seven equal parts
one part thereof I give to my wife and the other six
parts to my six children all which I give to them and
their heirs forever both Real & Personal And it is
further my Will & desire that in case my Executors
should find that my children any of them are not
brought up in a Christian like honest and Industrious
way under their mother That then my Executors take
them

to some Trade to good honest People as witness my hand
