Item I bind to my daughter Magdalene Walker three Negroes during her Natural life named Ammy, Little Frank & Lowrey, and at her death I give the s. three Negroes & the increase to my grandson William Walker to him his heirs & assigns forever. Item I give & bequeath to my grand daughter Mary Walker daughter of Warren Walker, my bed & furniture to her, her heirs & assigns forever, Item I give and bequeath to Martha Burton Grand Daughter of my Husband John Burton Dec^d, one Negro girl named Sarah to her, her heirs and assigns forever

Item I give and bequeath to my daughter Martha Ward my Frank & all my Clothes to her, her heirs & assigns forever

Lastly I do hereby Appoint my friend Com^r Booker Executor of this my Last Will & Testament for witness whereof I have hereunto set my hand & seal this 18th day of August 1781
