

In the Name of God, I move this Fourteenth of Feb<sup>y</sup> 1791  
the year of Our Lord Christ one thousand seven hundred & Eighty &  
W<sup>m</sup> Dunnivant being Old & weak in body but of perfect mind and  
Memory thanks be to God for it I do make and Ordain this to say prin-  
-pally and first of all I give & Recommend my Soul into the hands  
of Almighty God that gave it, and my body I recommend to the  
Earth to be buried in decent Christian burial at the discretion of  
my Executors Nothing doubting but at the General Resurrection  
I shall receive the same again by the Almighty power of God and  
as touching such Worldly Estate, wherewith it hath pleased God  
to bless with in this life, I give devise and dispose of in the following  
Manner and form.

I Give to my Loving wife Mary during her Natural life or while she  
remains and Widow the following Slaves Sara, Dico, Patt &  
Gilliam and Sam<sup>l</sup>, also I leave to my Dear wife my Land & Plantation  
where I now live during her Natural life or as long as she remains  
my Widow and Stock. I Give and bequeath to my Son Will<sup>m</sup>  
Dunnivant one negro Woman Patt & Hannah, Amos & Dawy, the said  
Negroes and their Increase to my said Son William and his heirs  
forever and ever, I Give and bequeath to my Son Hezekiah  
Dunnivant one negro named Winny, Samluler the said Negroes  
and their Increase to my said son Hez<sup>k</sup> & his heirs forever & ever  
I Give and bequeath to my Son John Dunnivant one Negro-  
boy named Gilliam and one Negro Girl named Phoe, the said  
Negroes and their Increase to my said son John and his heirs forever  
and ever and also I give to my said Son John one Feather Bed  
I Give and bequeath to my Son Daniel Dunnivant one Negro named  
Sam. and Finne the said and their Increase to my s<sup>d</sup> Son Daniel &  
his heirs forever and ever also I give to my said son Daniel one Feathered  
I Give and bequeath to my Son Abner Dunnivant one Negro  
named Sarah, and one negro boy Ned the said & their Increase to my  
said Son Abner and his heirs forever and ever also I give to my said  
son Abner one Feather Bed, — I Give and bequeath to my  
Daughter Phoeby Roberts one negro Woman named Judy and one  
Negro Girl named Dido the said Negroes & their Increase to my said  
Daughter Phoeby and heirs forever and ever  
I Give and bequeath to my Daughter Mary Dunnivant one

Negro a girl Dicky and one negro girl named Fanny  
Said negroes & their Increase to my Said Daughter Mary and  
her heirs forever & ever and also I give to my Said Daughters  
one Feather bed and also a horse and Saddle . . . . .

I give and bequeath to my two Sons Daniel and Abner  
my Land and Plantation where I now live to be equally divided  
between my two Sons Daniel and Abner and to their  
heirs forever & ever but my said Sons Daniel and Abner not to  
be possessed with the Said Land & Plantation before the decease  
or marriage of my dear wife Mary and then let them divide  
themselves and cast lots or draw for their Part . . . . .

I give and bequeath to my two Sons Hephiah and John  
my two hundred acres of Land I have in Prince Edward County  
to be equally divided to my said Sons Hephiah & John and their  
Heirs forever & ever and let them divide it themselves and then  
cast lots or draw for their Part, I lend to my loving wife Mary  
all the remainder part of my estate as I have not mentioned in  
my Will during her life or while she remains my widow and after  
the decease or marriage of my dear wife Mary then the said Goods  
and Chattels to be equally divided between John, Daniel, Abner  
and Mary and that they divide it themselves without the concern  
of any body, or the Trouble of the Cost, My Will and desire is that  
my three Sons, William, John and Daniel do Appoint executors of  
this my last Will and Testament denying all others or former Wills here  
before made by me and this only to be my last Will & Testament. *W*  
Witness hereto I have hereunto set my hand and affixed my Seal the  
day & year first above Written and desire that my Executors take my  
daughter Mary and let her live with them and take Care of her &  
what she has
