I Give & Bequeath To my Son Thomas Cousins my Plantation in Lunenburg County in the Fork of Mill's Creek containing three hundred & eighty four Acres to him & his Heirs for ever also one Negro Boy named Sam one Feather Bed & Furniture also two cows & Calves

I Give & Bequeath to my Son William Cousins the Plantation whereon I now live with all the Land I hold on Appomattox River containing six Hundred Acres also two Negro Boys named Darcy & Harry also two cows & Calves one Feather Bed & Furniture also my Brandey Still to him & his Heirs for ever my Will & Desire that my Wife may have her Life in the said Plantation

I Give my Daughter Martha one Negro Boy named Dick one Feather Bed & Furniture also two cows & Calves to her & her Heirs for ever

I Give my Daughter Mary one Negro Boy named Frank one Feather Bed & Furniture & two cows & Calves to her & her Heirs for ever

I Give my Daughter Anne one Negro Girl named Moll one Feather Bed & Furniture & two cows & Calves to her & her Heirs for ever

I Give my Daughter Phoebe one Negro Boy named Peter one Feather Bed & Furniture & two cows & Calves to her & her Heirs for ever

I Give my Daughter Francis one Negro Girl named Anne

Furniture shall be Equally Divided between my Son Wm Cousins & all
my Daughters after the Death or Marriage of my Wife ~ and
after all my Debts is paid

Heir I Give & Bequeath to my Beloved Wife all the Rest of my Estate
not before Given During her Natural Life or Widowhood Then to be
Equally Divided amongst all my Children my Desire is my Estate may
not be annulled Lastly I appoint my Beloved Brothers William & John
Cousins Executors of this my Last will & Testament in Witness whereof I have
here set my hand & Seal this 14th Day of August 1759.

At a Court held for Amelia County the 22^d Day of Novem^r 1759

Anderson their Security entered into & Acknowledged Bond according
