To my well beloved wife Lucy Clarke one Negro woman Ruth. To my daughter Hannah Clarke one Negro girl Rose. To my son James Clarke one Negro boy Johnne. To my loving wife Lucy Clarke the plantation I now live on during her natural life. To my son James Clarke all the land I am possess'd with. My estate shall not be devided before my daughter Hannah or my son James Clarke arrives to the age of twenty one years or marrys. Then my estate heretofore not given be equally devided between my wife Lucy and my two children Hannah and James Clarke, which the one third I lend my wife during her life. If my two children Hannah and James Clarke dyes without heir my wife Lucy Clarke shall have my whole estate dureing her natural life, then my whole estate be divided:
