Divided Between my five Children John, William, Jeremiah
Stephen & Sarah Farley to them & their heirs forever.

I appoint my beloved & Lawful Wife Sarah Farley &
William Farley Sen: Whole & Sole Executors of this my last
Will & Testament hereby Revoking all other Will or Wills as
heretofore made Appoint this only to be my Last Will &c.
