I Ordain this to be my last Will & Testament Humbly giving
my soul to almighty God that gave me & my body to be
Decently buried at the discretion of my Exors ~~burial~~ ^{burial} name
and as for what worldly Estate wherewith it hath pleased God
to bless me with in this life I give and bequeath in manner
& form following

First I leave to my
Beloved and Lawful wife Sarah Hudson the plantation where
I now live to include two hundred Acres of Land and One
Equal third part of all my estate during her ^{natural} life but at
her death I shall hereafter mention and at her death all
the Estate I have lent her excepting the Land to be equally
divided amongst all my Children to them their heirs & assigns
for ever

I then I leave and bequeath to my ^{beloved} Son
Burton Hudson all my Land lying on the North side
of the River James River in the County of James City

Burton Audon all my Land Lying on the North Side
of the Road that Leads for Burtons bridge to the Church
to him his heirs and Assigns for ever. — I then I
give and bequeath to my beloved Son John Audon all
my Land that Lies between Neals Branch & Burtons
Road to him his heirs & Assigns for ever. —
I then Give & Bequeath to my Loving Son Saml Audon
all the Remaining part of my Land Lying between
Neals Branch & the two hundred Acres I have be-
lent to my loving wife Sarah to him his heirs and Assigns
for ever. — I then all the remaining part of my
Estate I bequeath to be equally Divided amongst all my
Children to them their heirs and Assigns for ever. Lastly I
do hereby Appoint my Friends James Campbell and
Edmund Booker to be Executors of this my last Will and
Testament Revoking all former Will be me heretofore
made In witness whereof I have hereunto set my hand
& Seal this 26th day of January Anno Domini One
