Dodson to him and his Heirs forever. Provided

Never the less that if the said John Dodson or any of
his Heirs should sell the same that then it is my Will
And Devise that the said Heir at Law shall enter upon
And possess the same without any Demand from any
Person whatsoever.

Also I Give Devise and Bequeath unto my said Sister Ruth
Chambers all the rest Residues and Remainders of my Estate
Both Real and Personal to her and to heirs and Assigns forever.

Also I Devise that my Estate my not be Appraised and that my
Executors hereafter named pay all my Just Debts and
Funeral Expenses and that my Funeral be at her Descretion
and lastly I do appoint my said Sister Ruth Chambers
Executors of this my last Will and Testament hereby
Revoking all other Wills by me here before made either
by Word or in Writing Ratifying and Confirming this and
No Other to be my last will and Testament. Witnesses
Whereof I have hereunto set my Hand and Seal this 10th Day of

Such Heir then I give devise and Bequeath the said Land
and Plantation to John Dodson the son of Stephen
Dodson to him and his Heirs forever Provided

Never the less that if the said John Dodson or any of
his Heirs should sell the same that then it is my Will
And Devise that the Next Heir at Law shall enter upon
And possess the same without any Demand from Any
Person whatsoever

Also I give devise and Bequeath unto my said sister Ruth
Chambers all the rest Residues and Remainders of my Estate
Both Real and Personal to her and to her and Assigns forever

Also I Devise that my Estate may not be Appraised and that my
Executors hereafter named pay all my Just Debts and
Funeral Expenses and that my Funeral be at her Descretion
and lastly I do appoint my said sister Ruth Chambers
Executors of this my last Will and Testament hereby
Revoking all other Wills by me heretofore made either
by Word or in Writing ratifying and confirming this and
No Other to be my last will and Testament. Witnesses
