 this my last Will and Testament in manner following
 that is to say Principally and first of all I give and
 Recommend my Soul into the hands of God that gave it
 and for my Body I Recommend it to the Earth to be
 Buried in a Christian like and Decent manner at the
 Discretion of my Executors Nothing Doubting but at the
 General Resurrection I shall Receive the same again by the
 Power of God and as touching such worldly Estate wherewith
 it hath pleased God to Bless me in this life I give Devise & Dispose
 of the same in the following manner and foren after my
 lawful Debt to be paid

Imprimis I give and bequeathe to my Dear & well
 beloved wife Eve Lackey the plantation Innow here on all
 my Negroes Stock and all the Appurtenances ^{thereunto} belonging to Enjoy
 the same till my ~~son~~ well beloved son John Lackey cometh
 of age

Item I give and Bequeathe to my well beloved son John
 Lackey. Half of all my Land & Negroes Stock and I Personal
 Estate if the said my beloved wife is with in one year a Boy
 then my whole Estate to be Equally divided between the
 two and if it be a Girl then my said son John to have
 all the Land and half my Negroes and personally Estate
 and the Girl to have the other Half of the said Negroes
 Personal Estate and then they shall Allow my well
 beloved Wife Eve Lackey one third part of my whole
