

In the name of God Amen I John M. Canstane sick
of Bath County Virginia being of sound mind and memory
yet considering the uncertainty of human life, do make and
ordain this my last will and Testament in the manner fol-
lowing viz - In the first place I give and bequeath to my
grandson John M. Canstane one hundred and forty five acres
of land lying in Henric County to have and to hold to him
and his heirs forever - Then to my three grandsons Edward
Andrew and James M. Canstane each one hundred acres of
land lying in Kinawab County to have and to hold sepa-
rately and severally to them and their heirs forever - Then to
my grandson John M. Canstane I give and bequeath
225 Acres of land in this County on which I now live
to have and to hold to him and his heirs forever - Then to my
Daughter Jane Rhea I give and bequeath three hundred
Acres of land lying in Henric County to her to have and to
hold during the term of her natural life and after her decease
to be equally divided in fee simple between her three sons
John & Robert & Andrew Rhea - Then to my Daughter
Mary Sawyers three hundred Acres of land lying as aforesaid
to her to have and to hold during the term of her natural life
and after her decease to be equally divided among her three
sons Andrew Matthew & Alexander Sawyers in fee sim-
ple Also I will and direct that all the moneys wherewith I am
possessed in which may be due to me by bond note or otherwise
be equally divided between my son Andrew and my two
Daughters Jane Rhea and Mary Sawyers and I direct that
the Bond Note on Sampson Sawyers with the one on his
son Wm. the principal and Interest of both be received to my
daughter Mary as so much of her dividend and so what share
my son Andrew may be indebted to me be accounted to
him as so much of his share. Also I give to my Daughter
Mary my best the bolster and pillows and to my Daughter
Jane my ring and Corset. Also I give and bequeath to my

Son

Son Andrew in fee simple the tract of land whereon I now
reside also a Negro man named Lewis. I give to my son An-
drew with all the furniture therein which I may have
claimed heretofore and which have not been disposed of al-
ready - Lastly I constitute & appoint my son Andrew the
sole Executor of this my last will & Testament and I do
hereby revoke and disannul every former will by me made
In testimony whereof I do hereby set my hand this 9th
day of January 1811

William Peter Squire bequeath one hundred acres of land adjoining the right between my house and the River. To my son Jacob Pies Smith and bequeath one hundred acres of land on the south side of my Plantation next side to the vine patch. To my son James Smith and bequeath the Plantation Skin on that Straght of Henry Caswell being one hundred and thirty acres. As respecting my moveable property Horses &c with household furniture and farming Utensils I allow them to be equally divided between my wife and each of my children equally but my wife shall have the whole of the Cow cattle of every kind. In witness Whereof I have signed my name Elizabeth Pies to be my Execution to see my will performed. I have signed and made void all other testaments made by me or in my name heretofore but this to be my last will and Testament so help me God given under my hand and Seal August the 18th one thousand eight hundred and ten

The condition of the above Obligation is such that whereas the above bound James Cooper has been appointed a Constable in this County agreeable to an Act of Assembly concerning Constables now of the said James Cooper shall well and truly discharge the duties of his said Office of Constable agreeable to the said act of Assembly then the above Obligation to be void else to remain in full force
