of our Lord One thousand seven hundred & Eighty one Declared and
pronounced to be his Last Will and Testament in the presence of

to Law together with Nathaniel Tate and Henry Woodys his Co-sureties
entered into and Acknowledges their Bond in the penalty of One Hundred

presents. Republish all form or Will and Gifts of any kind whatsoever
and doth declare this to be his Last Will and Testament In Witness hereof I do
hereunto set my hand and Seal this Fifteenth day of March and in the Year
of our Lord One Thousand seven Hundred Eighty one. Declared and
pronounced to be his Last Will and Testament in the presence of

At a Court held for Bedford County, 11 day of Oct 1781.
This Will was proved according to Law by the Oaths of Nathaniel Sale and Henry
Wooddy the latter being sworn and ordered to be Recorded and thereupon no further
named in the said Will on the Motion of John Saunders who made Oath accord-
ing to Law & together with Nathaniel Sale and Henry Wooddy his clerk
entered into and Acknowledged their Bond in the Penalty of One Hundred
thousand pounds for Performance of said Will. Certificate is granted him for
Obtaining Letters of Administration on the Estate of Daniel Roberts deceased
the Testator with the Will annexed in due form. Teste Septoe 6.

Signed at Bedford County 11 day of Oct 1781
