make & Ordain this my Last Will & Testament. that in way principally &
first of all I give & Recommend my soul into the hands of God that
made all & for my Body I Recommend it to the earth to be Buried in a
Decent like manner at the Discretion of my Executors nothing doubting
but at the General Resurrection I shall receive the same again by the mighty
Power of God & as to such Worldly Estate wherewith it has pleased God to bless me
within this in this Life I give devise & Dispose of the same in manner &
form following that is to say In the first place I give & Bequeath to my dearly
Beloved wife Margrett Davis for & during her Natural Life all & singular my Lands
& Tenements together with all & every my Goods & Chattels to Bargain sell & dispose
of the Waresables or any part thereof if her need require it & after Death my devise is

that my Well Beloved son Henry Davis his Heirs or assigns do fully Possess & Enjoy
the said Lands above said to him or their only proper use & behoof forever. And as to
the moveable Estate I wholly leave to be disposed of by my said Dearly Beloved wife
Margrett Davis at her death as she shall think fit. And as touching my
Dearly Beloved children Samuel Davis Isaac Davis Lettice ~~Davison~~ Elizabeth
children Richard Davis & Zachary Davis having had their portion of goods
before therefore no need of mention further in this place as to my beloved son
John Davis I refer wholly & entirely to his Mother my Dearly Beloved Margrett
Davis Also I Will that all monies due me by right or conscience I give & bequeath
to my Dearly beloved Margrett Davis Lastly I constitute make & ordain my dear
Beloved wife Margrett Davis & my Well Beloved friend & Brother Henry Haynes the
sole Executors of this my Last Will & Testament & I do hereby utterly Disannul &
Revoke all & every other former Testament Wills & Legacies requests & Executors by
me in ways before this time named Willed & Bequeathed Ratifying &
confirming the words wrote upon this Single sheet of paper & another to be
