Lands, Messuages and Tenements whereon I now live by him to be possessed
and enjoyed after my death secondly the lands which I give unto my son
Adam after my death he is to pay unto his sisters and Brothers hereafter
mentioned the just and full sum of one hundred eighty dollars in
good property at cash price at the time and in manner following viz
Three years after my death he is to pay sixty dollars unto my Daughter
Eve now the wife Godwin Perloff if a live or not if not to her children
and this shall be her heritage together with all the property and

has pleased God to bless me in this life I give devise and
dispose of the same in the following manner and from
First I give and bequeath unto my son Adam all and singular my

dollars if alive or not to her children and this shall be her heritage
together with all the property and Money what she has already
received from me nine years after my death unto my son Andrew
Sixty dollars and this shall be his heritage together with all the property
and Money what he has already received if he is dead the said sixty dollars
to be paid to his heirs Lastly I do hereby ordain and appoint my son
Adam Thayer to be the sole executor of this my last will & Testament
and do hereby Revocably utter by swallow and drunk all and

among other former Testaments Legacies bequests and Executors by me in any
ways before named willed and be bequeathed ratifying and confirming the same
other to my last will and Testament

In witness whereof I have hereunto set my hand and seal this tenth Day of
January in the year of our Lord one thousand eight hundred and twenty four
