Wain whom I hereby nominate and appoint my executor I vest my whole
estate Real Personal and mixed whereever Situated. I Direct that
the Estate on which I live shall be kept in its present Condition
The Negroes I stock to be kept on it and the whole managed as nearly as
may be in the present plan by my executor for seven years the profits
to go to the support of my wife and the family and any profits that
may accrue over and above such support to be divided among
my two children.

Direct that my executor in making an adequate and suitable
provision for my wife should she be then living shall make a share
of all my Estate Real and Personal as equally as may be among
my five children namely Letitia Gamble, Elizabeth P. Watts, Malinda
Bowyer, Gary Breckinridge and John Breckinridge and to enable them
the better to do so, I authorize them to sell any real estate I may
possess whenever they may think proper Situated within the County
of Botetourt I Desire and Direct that the portion of my estate
which shall go to my Daughter Letitia Gamble shall be secured to
her during her life and to her heirs at her death. The house I
have built for the use of my son Gary I wish to be finished in a neat
but economical manner at the expense of my Estate and to enable
him to purchase a suitable residence for himself.

have built for the use of my son Gary, I wish to be finished in a ne-
ber economical manner at the expense of my Estate and to enable
him to finish it without incurring Debt, I release to him my inter-
est in the profits which have accrued at the Tannery. A Certificate of
Bank stock held by my wife for near or quite two thousand Dollars is
her own property, and is to be held by her as such. I do not
intend that the Children of my deceased Son Robert shall receive my
Portion of my estate, but that Herman and Winton shall to make
among the five other names of Herman that my estate above mentioned
may not be required to give any security, and I hereby revoke all former
wills. Each of my Children is to account for what he or she has
