of the County of Brunswick and State of Virginia being sick and weak in Body but of perfect mind and memory thanks be given unto God calling unto mind the mortality of my Body and knowing that it is appointed for all men once to die do make & Ordain this my last Will & Testament that is to say principally and first of all I give and recommend my soul unto the hands of Almighty God that gave it and my Body I recommend to the earth to be buried in decent Christian like burial at the discretion of my Executors nothing doubting but at the general resurrection I shall receive the same again by the mighty power of God And as touching such worldly estate wherewith it hath pleased God to bless me in this life I give devise and dispose of the same in the following manner and form First I give and bequeath to Nancy my dearly beloved wife all my Household goods and every thing now in my possession during her life and then to be equally divided between my four youngest Children Viz James Wright Wyatt Wright Lucy Wright and Tarry Wright. And I do hereby utterly disavow revoke and disannul all and every other former Testament Wills legacies bequests by me made in any wife before named Will and Bequeathed ratifying and confirming this and no other to be my last Will & Testament In Witness whereof I have hereunto set my hand and seal this fourteenth Day of February in the year of our Lord one thousand eight hundred and nine

Item my will & desire is that my Estate be not appraised lastly I do nominate and appoint William Johnson Executor to this my last will & Testament making good and well all others by me heretofore made I witness of the same I subscribe at my hand and seal this 17th day of January English 1810 and ten years sealed published and declared in the presence of
