William Vaughan Will In the name of God Amen I William
 Vaughan of the County of Brunswick and Behaving Sane being in full
 mind and memory do make this my last will as follows First I wish to
 my last debtly paid I have I give to my son Robert Vaughan all the
 Negroes that he has now in his possession that come from my Estate with all
 other property that I have given him hereafter to him & his heirs forever
 and nothing more of my Estate that I now possess or may hereafter possess except
 in Dollars in cash to be raised out of my Estate - The balance of my Estate
 that I now possess or may hereafter possess I leave to my wife I wish to be
 Equally divided amongst my wife Peggy Vaughan and her child called
 Rebecca Elizabeth Holman Vaughan and the child she is now pregnant
 with and my Daughters Sarah W Vaughan Mary Ann Vaughan
 & my son William Vaughan is to be divided amongst them as the Law direct. And
 to either of them should be not being possessed of a lawfully begotten heir his or
 her part is to be equally divided between the survivors and in that case Robert Vaughan
 children is to have an equal portion say one each. I wish the Commissioners who
 may be appointed to divide my negroes to have regard to the same and let as many
 as they can of the same family be in a lot except for such negroes that I have allotted
 to each one of my part of their legacy as follows I give to my wife (Peggy) Vaughan
 Opphor Daniels & her child of her legacy for life - I also give to her five
 acres which I have by her to her for ever - My will is that John Bailey
 be in part of Rebecca Elizabeth Holman Vaughters lot at their valuation My will
 is that Hannah & Margaret be in part of Sarah W Vaughters lot at their valuation
 My will is that Catherine & Mary be in part of Mary Ann Vaughters lot at their
 valuation - My will is also that Nancy & George be in part of William Vaughters
 lot at their valuation - I appoint Robert Watson William Reed jr. to act as my
 executor My moving is should either of my children Elizabeth Rebecca Holman
 Vaughan the child my wife is pregnant with Sarah W Vaughan Mary Ann Vaughan
 or William Vaughan be not possessed of a lawfully begotten heir that Robert
 Vaughters children shall have an equal portion of his share their part & no more
 At Witness my hand this 17th day of October one thousand eight hundred & five

 and on the motion of Robert Watson and William Rice Jr. the executors therein named
 they having made oaths thereto and the said Robert Watson with William Johnson and
 Robert Wallace his Securities and the said Rice with James Rice Jun^r Rice David
 Meredith & Benjamin Harrison his Trustees entered into and acknowledged themselves general
 bonds in the sum of thirty thousand Dollars each with condition as the said debts
 anticipate a grant of them for satisfying for debts therof & due from
