I give to John Fletcher Line and my desire my two Negro Men Archer & Will may be hired out at publick Auction till my Two Sons comes to age I them I do give and bequeath to my Son William Jones the Lower part of my Land and one Negro man known by the name of Archer I them I do give and Bequeth unto my Son Charles Jones the upper part of my Lands also one Negro Man known by the name of Will I them my will and Desire is that the Moneys - That is Raised by the Sale of the Negros May be Divided Equally amongst all my Children I them at the Decease of Maria of my wife my will & Desire is that the negro Woman Mary and all the Remainder part of my Estate In General may be Sold at Publick Auction and The Monies raised thereby be Equally divided between all my children Eliza Jones Judith Jones
