Wad Peterson all the Rest of my Estate Real and Personal Debts Demands and  
Demands whatsoever also I do hereby constitute and appoint the said  
Wad Peterson my whole and sole Executor of this my Last will and  
Testament In Witness whereof I have hereunto set my hand and seal this  
five day of September one thousand seven hundred and forty four.
