of St Andrews in the County of Brunswick being in health and
sound and disposing mind and Memory thanks be to
all mighty God for the same calling to mind the inner an-
time of my life I do make this my last Will and Testament
in manner and form following that is to say. First. I Request
my soul to God who gave it in the Advocacy and mediation
of our blessed Lord and Saviour Christ for Pardon of all my
past sins and my body I Commit to the Earth to be buried
Decently entered at this Discretion of my Executors hereinafter
mentioned and as to such Real Estate which it hath
pleased all mighty God to bestow on me I give and Dispose of
as follows to wit. I bequeath my house and Request unto my
wife Mary. My four Negroes Slaves that I had with in namely
Dias, Hannah, Ned and Jack as his absolute property, also the Stock
all out on the plantation I do call Husk & Powell's Preen with
all things thereon that I have any Right in or to

Sound and Discreet mind and Whom I thank &c.
let mighty God for the same calling to mind the inner an-
time of certain years do make this my last Will and Testament
in manner and form following that is to say: First I Request
my soul to God who gave it in the advocacy and mediocrity
of Jesus Christ and I do and I do give and I do give
my soul and my body I commit to the earth to be buried
I do hereby certify at this Discretion of my Executor hereafter
mentioned and as to such Worldly Estate which it hath
pleased almighty God to bestow on me I give and Dispose thereof
as follows to wit: I give and I give and I give unto my wife
Elizabeth the two Negroes Slaves that I had with me namely
Dias Hannah and Jack as her absolute property, also the Stock of
all sort on the plantation of her late Husband Russell Brown with
all the things thereon that I have any right in
I give and I give and I give to her and to her heirs and assigns
forever and I do hereby certify that I have no other Will

and of my tract which I have sold and to include the plantation that
my said son has already made thereon also six Negroes to Wit.
Abraham & small his Wife, Will. Isaac, Phoby and Amy.
Item I give and Devise unto my son Richard Wall and to his Heirs
the good and sound and a piece of said part of my tract in the said
County of Brunswick containing four Thousand and Nineteen Acres, to be
Taken off as to John Volentine Whites, William Haly and Hugh Larnier
and the region Root Creek, also six Negroes, to Wit. Sam and Liddy his
Wife, Beck and Charles, Frank and Margaret.

Item I give and Devise unto my beloved Wife, Mary one Thousand Acres of my
said Tract off from the said land Nineteen Acres of land to be taken in the
West end thereof & to John Logan Selman and David Walker and the County
Lives for and during the term of his Natural life, and some and immediately
thereof for I give and devise the same unto my son George Wall and to his
Heirs and assigns forever. Item I give and bequeath unto my son
George Wall four Negroes Viz. Tom a man, Abraham a boy & Lucy a woman.

Item all the rest and Residue of my Estate in possession Remainder and
Reversion in what Manner Qualities & under the same as and in the same

I do hereby give and devise all the lands and tenements and
 personal estate which I now possess to the said John Wall
 after payment of my debts and several charges and
 services as mentioned. I give Bequeth and devise unto my son
 John and to his Heirs and Assigns forever and I do appoint my said son
 John my sole Executor of this my Last Will and make him
 Disannulling and making void all other and former Testaments of me
 at any time heretofore made Intestimonies witness my hand and
 official my seal this fourth day of June in the second
 Hundred and fifty two...
