order this to be my last Will and Testament
that is to say Principally and first of all I give
and Recommend my soul into the hands of
almighty God that gave It and my Body
recommends to the earth to be buried in a
decent christian manner nothing doubting
but I shall receive the same again at

the general resurrection by the mighty Power of God
and as touching the worldly estate which with It
hath pleased God to bless me in this life I give
devise and dispose of the same in the following
manner and form Viz; and first in my devise
is that all my Just debts be Justly paid
and satisfied Inpursuance I give and bequeath
unto my son Richard Daniel the plantation
and Tract of Land whereon he now lives contain-
ing one hundred acres more or less to him and
his heirs for ever Item I give and bequeath
unto my daughter Lucy Tent one Shilling
Sterling I give to my son Peter one shilling Sterg
I give to my daughter Sarah Darsy one shilling
Rs. 2 - 10 - 0

Starling I give to my son Peter one shilling Sterg
I give to my daughter Sarah Daisy one shilling
Sterling I give unto my sons William and John
one shilling Sterling each. Item I bequeath unto my
daughter Fannia Hinton the Plantation she
now lives upon during her natural life if
she chooses to live upon the same

to live along with
her if he chooses to do so. Item I bequeath unto my
loved wife Mary Daniel the Plantation and Tract of
Land whereon my son Peter now lives containing
fifty acres more or less with all my household
furniture and moveable property during her
natural

natural life or widowhood and after her decease
If my Son Peter ^{Daniel} uses his mother well as long as
she lives he shall have y^e fifty acres of Land
more or less whereon he now liveth to him and
his heirs for ever and I do hereby utterly dis-
allow revoke and disannul all former Wills and
Testaments by me in any wise made or made
Ratifying & confirming this and no other to be
my last Will and Testament In witness whereof
I have hereunto set my hand and seal the day
and year first above written. ^{his} Peter X Daniel ^{mark}
