two of the Wm fore hereto subscribed, and Ordered to be Recorded, on the
Motion of the said Executor who made Oath according to Law Certificate
is granted him for obtaining a Probate of the said Will in due form
he giving security, whereupon he together with Thomas Hord and Adam
Birch his Sureties entered into and Acknowledged their bond for
that purpose, Mary Bargin, Widow and Relict of the said Daniel
Bargin came into Court, and Renounced all benefit of the Legacies
left her under the said Will, and Claimed her thirds of the s^d Estate
according to Law, and also Relinquished her Right of Execution as
an Executor to the said Will.
