of the County of Charlotte in Virginia, being of perfect mind and memory  
thanks be to God for the same and calling to mind the mortality of my  
body and knowing that it is appointed for all men to die do make this  
my last Will and Testament that is to say Principally and first I give  
and recommend my soul to God that gave it to me, and for my body I  
recommend it to the earth to be buried in a Christian like manner according to the  
Custom of our Exccutors hereafter mentioned nothing doubting but at the General  
resurrection to receive the same by the mighty Power of God and as touching my worldly estate  
I have with it both Pleased Almighty God to bless me I give and bequeath in manner and form  
following, <sup>And first</sup> It is my desire that all my just debts and funeral charges be first  
paid, Item I leave to my loving wife Jane Hannah one Negro man named Jack &  
one Negro woman named Phebe, and all my household furniture my Stock of horses,  
cattle, Sheep and hogs During her widowhood and at her decease to be equally  
divided among all my Children. Item I give to my son John Hannah all my  
white Blacks with ~~my~~ Tools. Item I give to my Daughter Isbell Hannah one  
Negro boy named Gowin, Item, I give to my Daughter Judah Hannah one  
Negro Girl named Lucy, <sup>Item</sup> It is my desire that if my Negro woman  
should have another Child that it is now given to my daughter Mary

a receipt it hath Please Almighty God to Bless me I give and bequeath in manner and form  
following, ~~It be is~~ It is my desire that all my Just debts and funeral charges be first  
paid, Item I leave to my loving wife Jane Hannah one Negro man named Jack &  
one Negro woman named Phebe, and all my household furniture my Stock of Horses,  
Cattle, Sheep and hogs. During her widowhood and at her decease to Equally  
divided among all my Children. Item I give to my son John Hannah all my  
working Blacks with's ~~working~~ Tools. Item I give to my Daughter Isbell Hannah one  
Negro boy named Gowin, Item, I give to my Daughter Judah Hannah one  
Negro Girl named Lucy, Item it is my desire that if my Negro woman  
should have another Child that it is now <sup>to be</sup> given to my daughter Mary  
Elenor and in case she should not have a Child that the Value of a young  
Negro be paid to her out of my Estate and that she may <sup>be</sup> Educated proper for  
a Girl, to be paid for out of my Estate, Item if any of my Children should  
marry it is my desire that they may be provided for as those of my Children that  
are married has been and to be paid the same out of my estate if it will admit  
of it if not to be paid according to the discretion of my Executors hereafter  
mentioned. Item, I do constitute and appoint my son Andrew Hannah  
and my son John Hannah Executors of this my Last Will and Testament, In  
Witness whereof I have hereunto set my hand and seal this Twelfth  
day of February in the year of our Lord 1783. George Boudin, L.

Signed, Sealed and declared by the said George Hannah to be his last Will and Testament in presence of us Peter Harllee, William Johnston David Hannah.

At a Court held for Charlotte County the fifth day of May 1783.

This Last Will and Testament of George Hannah decd. was Exhibited in Court by Andrew Hannah and John Hannah the Executors therein named and the same was proved by the oaths of Peter Harllee and William Johnston two of the Witnesses hereto Subscribed, and ordered to be Recorded. On the Motion of the said Executors who made oath according to said Certificate is granted them for obtaining a probate of the said Will, They giving security. Whereupon they together with Richard Gaines Junr, William Price, Joel Townes and James Stetchoe their securities entered into and Acknowledged their bond for that purpose.
